

## HACCP Recharge

Program Outline	<p>This seminar is for <b>production managers, quality assurance</b> and <b>HACCP champions</b> or <b>team leaders</b> needing to refresh their knowledge and application of the Codex HACCP Food Safety System and get up to date with changes in food manufacturing legislation, codes of practice, customer standards and agrifood industry issues.</p>
